ADDS is the treatment provider for the Eighth Judicial District (8b) Drug Court. We provide treatment coordination, treatment services and program development. Drug Court is a program of the Judicial System which then contracts with ADDS to provide the necessary treatment to those involved. Services include assessment, case management and others.

Recovery Management

ADDS recovery management program is provided for any client who has completed a treatment program. This program is held 1 time every other week.. The objective of the program is to assist clients to maintain sobriety and be able to share any concerns, problems and solutions.

Substance Abuse Outpatient Services

Extended Outpatient Treatment (Level 1) is offered in Burlington, Wapello, Keokuk and Mt. Pleasant. This consists of individual, family and group counseling for both adults and juveniles. Level 1 treatment duration is dependent upon client needs and progress through the individualized treatment plan. We provide evaluations for those charged with OWI along with any other required evaluations. We can assist with crisis intervention when necessary in office. We can create referrals to other offices and levels of care if necessary. Our offices are able to offer materials for Spanish speaking clients in need of treatment. Clients are asked to provide their own interpreter. The Wapello office does a number of evaluations for both Spanish and Burmese speaking clients. Counseling over the phone and via Recovery is available.

Intensive Outpatient Treatment (Level 2) is offered in the Burlington office. This is held in a group setting and consists of 9 hours of treatment per week. Individuals are available upon request and need assessed by counselor.

Fees for outpatient treatment are offered on a sliding fee scale and are based on income for Iowa Residents.

Residential Services

Residential treatment is offered in our Burlington office. We have a 20-bed facility that is co-ed for adults. The clients are active in the community, attend outside support and self-help groups as well as in house meetings. We take referrals from throughout the state. Duration is dependent upon client needs and progress through the individualized treatment plan. The clients are involved in groups, individual sessions as well as family therapy when possible.

Distance Treatment – ADDS provides treatment via phone, email, and the encrypted Recovery webpage for Level 1 and Level 2 services.

Access to Recovery and Recovery Support Services

These are programs that offer assistance to help clients remove barriers to treatment. An example of the services available to clients is bus passes, gas vouchers, clothing allowances, and help with some medications. This is just an example of the help available. This service is available in the Burlington, Mt. Pleasant, and Keokuk offices.

Prevention Department

The prevention department provides the following services: drug free workplace information and training, juvenile diversion, OWI classes, educational level of "treatment", breath alcohol testing and urinalysis. The prevention department is involved in the surrounding school systems to provide education to the students, with Community Coalitions, and other community organizations.

OWI program teaches specific research based guidelines. It also helps participants to develop a specific action plan to avoid further problems with alcohol or drugs. The 12 Hour OWI course meets the Department of Education and Department of Transportation requirements under Iowa law.

Gambling Treatment Services

Gambling Treatment and Prevention Services are offered in the Burlington, Mt. Pleasant, Keokuk, Wapello, Ottumwa, and Bettendorf offices. They include several counties. Evaluations are provided and recommendations for treatment will be given when necessary. Duration is dependent upon client needs and progress through the individualized treatment plan. Phone counseling, web-based counseling, group, and individual sessions available on an outpatient basis.
